Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to the Articles of Incorporation:

- 1. The name of the Corporation is RAFCO PROPERTIES, INC.
- 2. Article 7.3 of the Articles of Incorporation of the Corporation is hereby amended in its entirety to provide as follows:
  - "7.3) Number of Directors. The Board of Directors shall be not less than one (1) in number. The number of Directors may be increased and, if increased, thereafter decreased to a number of not less than one (1) by the shareholders of this Corporation."
