RESTATED ARTICLES OF INCORPORATION

OF

TIB BANK

Pursuant to Section 607.1006, Florida Statutes, the Restated Articles of Incorporation of TIB Bank are hereby amended as follows:

<u>FIRST</u>: Article III of the Restated Articles of Incorporation is hereby amended by deleting the text thereof in its entirety and substituting the following in lieu thereof:

The general nature of the business to be transacted shall be that of the general commercial banking business, with the right and authority to engage in trust business and act as a fiduciary to the fullest extent permitted by law, and with all the rights, powers, and privileges granted and conferred by the Florida Financial Institutions Codes, regulating the organization, powers and management of banking, corporations.

SECOND: The foregoing amendment was adopted by the holder of all of the outstanding shares of common stock, being the sole voting group entitled to vote on the amendment, on August 28, 2008 and the number of votes cast for the amendment was sufficient for approval by the holder of common stock.
