ARTICLES OF INCORPORATION  
OF**

The Second Amended and Restated Articles of Incorporation of Sound Advice, Inc. are hereby amended and restated in their entirety as follows:

**ARTICLE I**

**NAME**

The name and address of this corporation shall be:

**ARTICLE II**

**NATURE OF BUSINESS**

The general purpose for which this Corporation is organized is to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

**ARTICLE III**

**AUTHORIZED SHARES**

This Corporation shall be authorized to create and issue 100 shares of Common Stock having a par value of \$.01 per share.

**ARTICLE IV**

**TERM OF EXISTENCE**

The term of this Corporation commenced with the original filing of the Articles of Incorporation. The Corporation shall exist perpetually unless dissolved according to law.


