#### ARTICLES OF AMENDMENT

### REGISTERED AGENT CORPORATION (old name)

Pursuant to the provisions of Section 607.181, 607.187, and 607.194 of the Florida General Business Corporation Act, REGISTERED AGENT CORPORATION hereby adopts the following articles of amendment for the purpose of amending its articles of incorporation, as follows:

- 1. The present name of this corporation is REGISTERED AGENT CORPORA-TION, having been changed to that from its original name of "American Service Industries, Inc." on 25 March 1976.
- 2. The date of the adoption of this amendment by both the board of directors and shareholders of this corporation is 25 March 1998.
- 3.
