

1. Article II of the Articles of Incorporation of Jones, Edmunds & Associates, Inc. is amended by adding the following subparagraph:


"q. To furnish, from its office in Titusville, Florida, services in connection with the design and construction of a structure or group of structures which have as their principal purpose human habitation or use, and the utilization of space within and surrounding such structures. These services will include planning, providing preliminary study designs, drawings and specifications, job-site inspection and administration of construction contracts."


2. Article IX of the Articles of Incorporation is amended by adding the following sentence:
