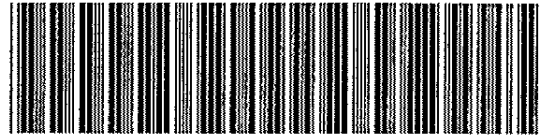

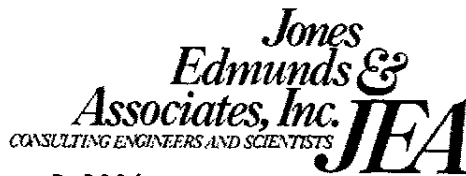

1. Article II of the Articles of Incorporation of Jones, Edmunds & Associates, Inc. is amended by adding the following subparagraph:

“r. To furnish services in connection with the practice of surveying and mapping as defined in Chapter 472, Florida Statutes.”

2. Article IX, Paragraph A, of the Articles of Incorporation is amended by adding the following sentence:
