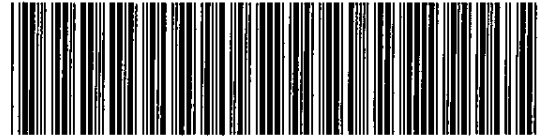




"A. Joseph O. Snearly shall serve as Vice President for Architectural Services with responsible supervisory control of all such services."
