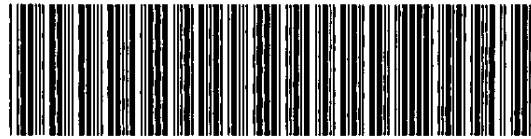



**A Florida Corporation**



IN WITNESS WHEREOF, the undersigned President and Secretary of the Corporation have executed these Articles of Amendment on May 31, 2012.


