ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF AYRES, CLUSTER, CURRY & McCALL, P.A.

This Articles of Amendment to the Articles of Incorporation of AYRES, CLUSTER, CURRY & McCALL, P.A. is made pursuant to Florida Statutes Section 607.1006.

1. The Articles of Incorporation of AYRES, CLUSTER, CURRY & McCALL, P.A., a Professional Association, filed on May 27, 1974, and amended on June 16, 1975, on June 20, 1978 and on February 22, 2000, effective March 1, 2000, are hereby amended, and Article I shall hereafter read as follows:
