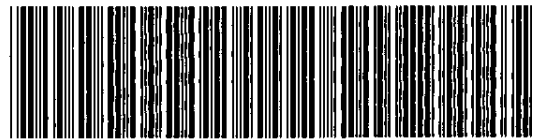



This Articles of Amendment to the Articles of Incorporation of **AYRES, CLUSTER, CURRY, McCALL, COLLINS & FULLER, P.A.**, is made pursuant to Florida Statutes Section 607.1006.

1. The Articles of Incorporation of **AYRES, CLUSTER, CURRY, McCALL, COLLINS & FULLER, P.A.**, a Professional Association, filed on May 27, 1974, and amended on June 16, 1975, on June 20, 1978 and on February 22, 2000, effective March 1, 2000, and amended on June 19, 2001, effective July 2, 2001, are hereby amended, and Article I shall hereafter read as follows:

**ARTICLE I - NAME**

The name of this Professional Association is **AYRES, CLUSTER, CURRY, McCALL & COLLINS, P.A.**

2. The foregoing Amendment, pursuant to Florida Statutes Section 607.1003, was adopted by unanimous vote of the Board of Directors at a lawfully constituted meeting of the Board of Directors held on June 1, 2011. 
3. This Amendment was adopted on June 1, 2011 and shall be effective as of June 1, 2011.
