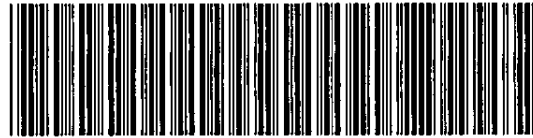



**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF  
AYRES, CLUSTER, CURRY, McCALL & COLLINS, P.A.**

This Articles of Amendment to the Articles of Incorporation of **AYRES, CLUSTER, CURRY, McCALL & COLLINS, P.A.**, is made pursuant to Florida Statutes, Section 607.1006.

1. The Articles of Incorporation of **AYRES, CLUSTER, CURRY, McCALL & COLLINS, P.A.**, a Professional Association, filed on May 27, 1974, and amended on June 16, 1975, on June 20, 1978 and on February 22, 2000, effective March 1, 2000, and amended on June 19, 2001, effective July 2, 2001 and amended on June 1, 2011, are hereby amended and Article 1 shall hereafter read as follows:

**ARTICLE I - NAME**

The name of this Professional Association is **AYRES, CLUSTER, CURRY, McCALL, COLLINS & BANKS, P.A.**

2. The foregoing Amendment, pursuant to Florida Statutes Section 607.1003, was adopted by unanimous vote of the Board of Directors at a lawfully constituted meeting of the Board of Directors held on March 27, 2012. The Board of Directors then recommended the amendment to the Shareholders for approval. Thereafter, the Shareholders at a lawfully constituted meeting held on March 27, 2012, adopted by unanimous vote the recommended amendment. The number of votes cast for the amendment by the Shareholders was sufficient for approval.


3. This Amendment was adopted on March 27, 2012 and shall be effective as of April 1, 2012.

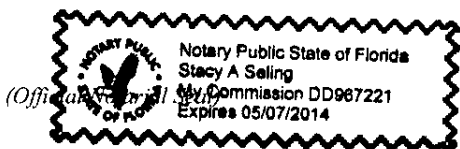
