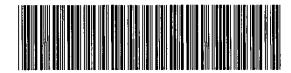

## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF PAVER DEVELOPMENT CORPORATION

The undersigned, certifies that:

- 1. She is the President of PAVER DEVELOPMENT CORPORATION., a Florida corporation, whose Articles of Incorporation were filed with the Secretary of State, State of Florida, on June 18, 1974, as amended.
