BUSCIGLIO, D.D.S., M.S., P.A., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I
Name

The name of the corporation is ORTHOWORKS, AN ORTHODONTIC DENTAL FACILITY, JOHN A. BUSCIGLIO, D.D.S., M.S., P.A. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on June 29, 1974.
