The undersigned, being the President of FLORIDA PRESS CENTER, INC., a Florida corporation (the "Corporation"), desiring to dissolve the Corporation in accordance with the Florida Business Corporation Act, hereby submits the following:

ARTICLE I

The name of the Corporation is FLORIDA PRESS CENTER, INC.

ARTICLE II

The dissolution of the Corporation was authorized on May 29, 1998.

ARTICLE III

The dissolution was approved by unanimous written consent of the shareholders of the Corporation on May 29, 1998 in accordance with the provisions of Sections 607.0704 and 607.1402(6) of the Florida Statutes, which was sufficient for approval.

ARTICLE IV

These Articles of Dissolution shall be effective upon filing with the Secretary of State.

The undersigned President, for the purpose of dissolving FLORIDA PRESS CENTER, INC. under the laws of the State of Florida, has executed these Articles of Dissolution as of this 29 day of May, 1998.
