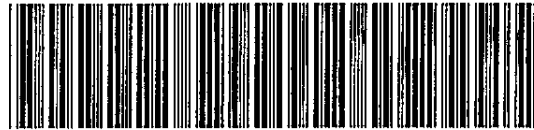

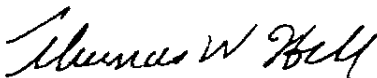
Dear Sirs/Madam:
