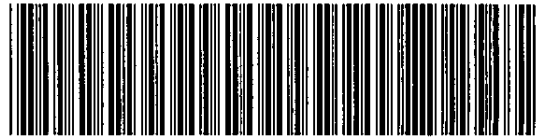

ARTICLE I - NAME

The name of this Florida for profit corporation is Casdore FL., Inc., which was formerly known as Carvy Corp.

ARTICLE II - DATE OF FILING

The Articles of Incorporation were filed with the Florida Department of State, Division of Corporations, on January 17, 1975 and the corporation was assigned Document No. 470854. Articles of Amendment changing its name from Carvy Corp. to Casdore FL., Inc. were filed on or about June 29, 1992.

ARTICLE III - APPROVAL OF DISSOLUTION

The sole shareholder of this Florida for profit corporation, Casdore Int'l Ltd., a B.V.I. corporation, has authorized its dissolution.

ARTICLE IV - EFFECTIVE DATE OF DISSOLUTION

This Florida for profit corporation shall be dissolved effective with the filing of these Articles of Dissolution with the Secretary of State of the Florida Department of State.

ARTICLE V - DEBTS AND LIABILITIES

This Florida for profit corporation has set aside a reserve for winding-up and dissolution expenses. There are no other debts or liabilities owed by this Florida for-profit corporation.

ARTICLE VI - DISTRIBUTION OF ASSETS

This Florida for-profit corporation will, subject to the reserve set forth above, make distribution of all of its assets to its sole shareholder, Casdore Int'l Ltd, a B.V.I. corporation.

ARTICLE VII - PENDING SUITS

This Florida for-profit corporation has no suits pending against it in any Court.
