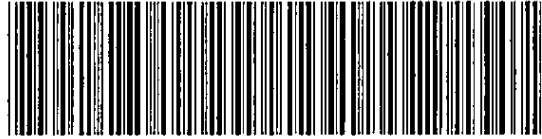

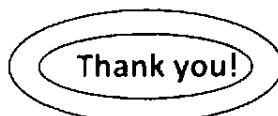

**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION OF  
CORTEZ FOOT & ANKLE SPECIALISTS, P.A.**

The undersigned, certifies that:

1. He is the President of **CORTEZ FOOT & ANKLE SPECIALISTS, P.A.**, a Florida corporation, whose Articles of Incorporation were filed with the Secretary of State, State of Florida, on March 3, 1975, as amended.

2. The following amendment to the Articles of Incorporation was unanimously adopted and approved by the Shareholders (the "Shareholders") and Board of Directors (the "Directors"), by written consent in lieu of a special meeting, dated August 19, 2022.
