Pursuant to the provisions of Section 607.1006 of the Florida Business

Corporation Act (the "Act"), the undersigned corporation has adopted the following Articles of

Amendment to its Articles of Incorporation:

I. The name of the corporation is CACHE, INC. (the "Corporation").
