


1. The name of this corporation is ECONO AUTO PAINTING OF PENSACOLA, INC.

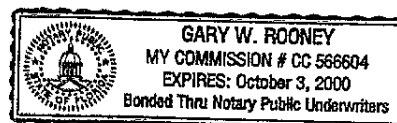


