**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
REINMAN, HARRELL, MITCHELL & WATTWOOD, P.A.**

The Articles of Incorporation of Reinman, Harrell, Mitchell & Wattwood, P.A. are hereby amended as follows:

- I. The name of the corporation shall be R&H ASSETS, INC.
