THIRD ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF MONOGRAM INTERNATIONAL, INC.



Pursuant to Section 607.1003 of the Florida Business Corporation Act, Monogram International, Inc. adopts these Articles of Amendment:
