**FIRST:** Amendment(s) adopted: Article I-Name of Corporation shall be amended to STONEY TWO, INC.

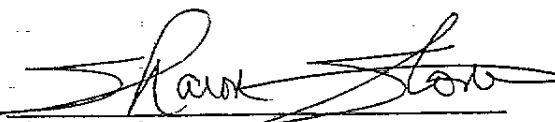
