Sections 607.0704 and 607.0821 of the Florida General Corporation Act.

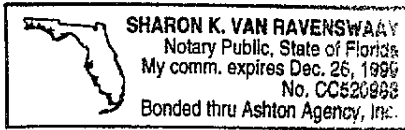
ARTICLE FOURTH: The effective date of these Articles of Amendment shall
