Thank you for your prompt attention in this matter. Please call me if you have any questions.

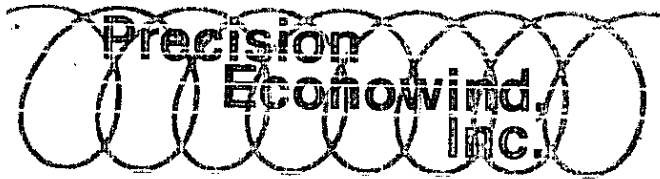
