ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF BARNETT, BOLT, KIRKWOOD, LONG & McBRIDE, P.A.

Pursuant to Section 607.1006 of the Florida Statutes, the Articles of Incorporation of BARNETT, BOLT, KIRKWOOD, LONG & McBRIDE, P.A., a Florida professional corporation (the "Corporation"), are hereby amended as follows:

- 1. The name of the Corporation is BARNETT, BOLT, KIRKWOOD, LONG & McBRIDE, P.A.
- 2. Article 1 of the Articles of Incorporation of the Corporation is hereby amended to

read as follows:

"ARTICLE I

The name of the corporation is:

Barnett, Bolt, Kirkwood, Long & Koche, P.A."

- 3. The foregoing amendment was adopted as of January 1, 2015, by the watten consent of the shareholders of the Corporation in accordance with the provisions of Sections 607.1003(6) and 607.0704 of the Florida Statutes.
