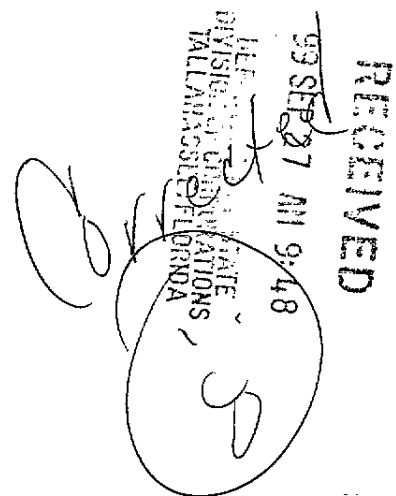

WHEREAS West Realty, Inc. was incorporated by its stockholder on the 2nd day of September, 1975, under the laws of the State of Florida and was assigned Charter Number 483748, and

WHEREAS an Amendment to the Articles of Incorporation of West Realty, Inc. changing its name to Investment of F & H, Inc., a Florida corporation was filed on December 13, 1983 in the office of the Secretary of State of the State of Florida and continued its assignment as Corporation Number 483748, and

WHEREAS the corporation is now known as Investment of F & H, Inc., and


