RESOLVED, that a change of Article I of Florida Kids Corporation, be made in the Articles of Incorporation, and that the Board of Directors determined that the same be changed to:

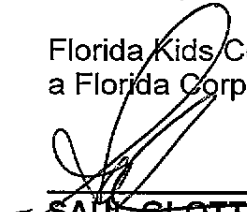
VISTA ASSOCIATES CORPORATION

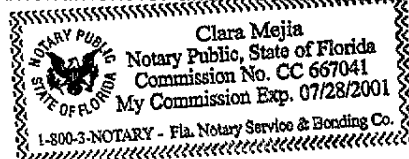

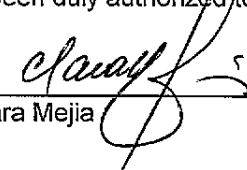
