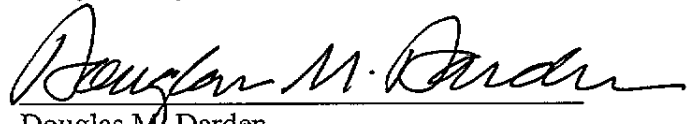
1. Article I of the Articles of Incorporation is amended to read as follows:
