ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF ACME MANUFACTURING, INC.

Pursuant to Sections 607.1003 and 607.1006 of the Florida Statutes, Acme Manufacturing, Inc., a Florida corporation, hereby adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is Acme Manufacturing, Inc.
- 2. The following amendment to the Articles of Incorporation was adopted by the Shareholders (the number of votes cast being sufficient for approval) and the Directors of the Corporation by the Written Consent of Shareholders and Directors in Lieu of a Special Joint Meeting dated September 24, 1993 in the manner prescribed by Sections 607.1003 and 607.1006 of the Florida business Corporation Act:

"ARTICLE I

The name of the Corporation shall be Atlass Contract Hardware, Inc."

3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
