

AMENDMENT TO ARTICLES OF INCORPORATION OF

JAMES R. HOMAN, D.O., P.A.

Pursuant to the provisions of Section 607.1006, Floreda Statutes, this corporation, JAMES R. HOMAN, D.O., P.A., adopts the following Articles of Amendment to its Articles of Incorporation, filed with the Secretary of State for the State of Florida on December 4, 1975, as document number 492021.

The following amendments are made:

1. Article I is amended to provide as follows:

ARTICLE I

Article II is amended to provide as follows:
