1. Article I is amended to provide as follows:

ARTICLE II

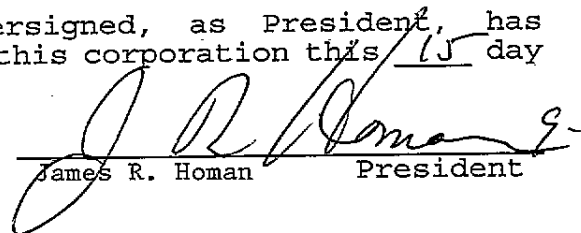
This Corporation may engage in any business permitted of a corporation organized under Chapter 607, Florida Statutes, including without limitation the practice of medicine.
