Dear Examiner,

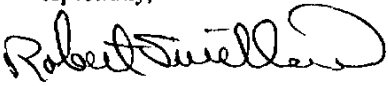
We received the 1998 Profit Corporation Annual Report Packet - 2nd Notice in the mail. We never received the first mailing which was due earlier this year.
