3. Upon the effectiveness of the foregoing amendment, the name of the professional association shall be and become Charles L. Prizzia, D.D.S., P.A.



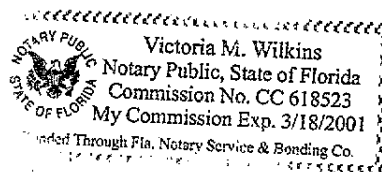
