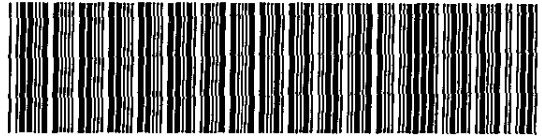

ARTICLE I - NAME

ARTICLE IV - DEBTS OF CORPORATION


There are no debts of the LOW-JO, INC. that remain unpaid.
