AMENDMENT TO ARTICLES OF INCORPORATION

Each class of shares shall be identical in all respects except the non-voting shares shall carry no right to vote for the election of Directors of the Corporation, and no right to vote on any matter presented to the Shareholders for their vote and approval, except only as the laws of the State of Florida require that voting rights be granted to non-voting shares.

(B) <u>Voting Shares</u>. All shares of stock issued and outstanding prior to the adoption of this Amendment shall be classified as voting shares."
