ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION
FOR
SAHARA CABINETS, INC.

Pursuant to F.S. 607.1003, the Articles of Incorporation for Sahara Cabinets, Inc., a Florida Corporation are amended as follows:

1. Article III is hereby amended to provide that the amount of capital stock that the Corporation shall be authorized to issue shall be One Thousand (1,000) shares of One (\$1.00) Dollar par value stock, which said stock shall be non-assessable and shall be held, sold, and paid for at such time and in such manner as the Board of Directors may from time to time determine. 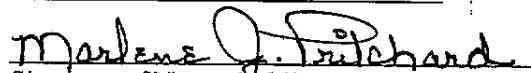
