ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF <u>VIROGROUP, INC.</u>



Pursuant to the provisions of Section 607.1106 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is VIROGROUP, INC. (the "Corporation"), Charter #503390, filed on May 18, 1976.
- 2. The following Amendment to the Articles of Incorporation was adopted by all of the Directors of the Corporation and all of the Shareholders of the Corporation, the number of votes cast being sufficient for approval, on January 23, 1997 in the manner prescribed by Section 607.1003 of the Act:

At 5:00 p.m., Eastern time, on the date of the filing of this amendment to the Articles of Incorporation, all outstanding shares of Common Stock held by each holder of record on such date shall be automatically combined at the rate of one-for-eight without any further action on the part of the holders thereof or this Company. No fractional shares shall be issued. In lieu of issuing fractional shares, the Company's transfer agent will sell any such fractional shares at the then prevailing price on the Nasdaq SmallCap Market. The Company's transfer agent shall determine the amount of the net proceeds of the sale to which each holder of fractional shares is entitled, and shall, as soon as practicable after such determination has been made, mail such amount, without interest, to such holders.

IN WITNESS WHEREOF, the undersigned being the Assistant Secretary of the Corporation has executed these Articles of Amendment to Articles of Incorporation of VIROGROUP, INC. this 23rd day of January, 1997.
