**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF

1. The text of the amendment to the Articles of Incorporation is:

Article VI of the Articles of Incorporation is hereby deleted and the following is substituted in its place:

**ARTICLE VI**

The Corporation shall have the authority to issue  
10,000 common shares with a par value of \$1.00 per share.
