**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION  
OF**

MR. BUILD, MANASOTA ALUMINUM PRODUCTS, INC.

PURSUANT to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendments to its Articles of Incorporation:

- (1) The name of the corporation is MR. BUILD, MANASOTA ALUMINUM PRODUCTS, INC.
- (2) The text of the amendment is as follows:

Article 1 is hereby amended to read: The name of this corporation shall be "MR. BUILD, INC."

- (3) The amendment does not provide for an exchange, reclassification or cancellation of issued shares.
- (4) The amendment was adopted on the 25 day of March, 1997.
- (5) The amendment was adopted by a shareholder action at a special shareholders meeting, pursuant to Notice and Call, as required under Chapter 607 and the ByLaws. The amendment was approved by a majority of the shareholders of the only class of stock outstanding. A quorum was present at the meeting. The votes cast for the amendment was sufficient for approval by that voting group.
