**AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
GEORGE'S CRANE SERVICE, INC.**

1. Pursuant to the provisions of Florida law, the undersigned Corporation adopts the following Amended and Restated Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is GEORGE'S CRANE SERVICE, INC.

ARTICLE II

Duration

This corporation shall have a perpetual existence, unless dissolved according to law and, commenced on the 10th day of June, 1976.

ARTICLE III

Purpose

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE IV

Capital Stock

The Corporation is authorized to issue one hundred (100) shares of One Dollar (\$1.00) par value common stock which shall be designated "Class A Voting Common Shares"; and one hundred (100) shares of One Dollar (\$1.00) par value common stock which shall be designated "Class B Nonvoting Common Shares". The Class A and Class B shares shall be entitled in all respects to equal rights and privileges except that each share of Class A shall be entitled to one (1) vote and each share of Class B shall be nonvoting stock.

ARTICLE V

Principal Office; Registered Office and Agent

The street address of the principal office of this corporation is: 2190 N.W. 110 Avenue, Miami, Florida 33172. The street address of the registered office of this corporation is: C/O Therrel Baisden, P.A. 1 SE 3rd Avenue Suite 2950 Miami, Florida 33131, and the name of the registered agent of this corporation is: Mark M. Hasner, Esq.

ARTICLE VI

Board of Directors

This corporation shall have two (2) directors. The number of directors may be increased or decreased from time to time by the By-laws, but shall never be less than ONE (1). The names and addresses of the directors of this corporation are:

2. The number of shares of the Corporation outstanding at the adoption was FIVE HUNDRED (500), and the number of shares entitled to vote thereon was FIVE HUNDRED (500).

3. The number of shares voted in favor of such Amendment was FIVE HUNDRED (500), and the number of shares voted against such Amendment was none. The number of votes cast in favor of such Amendment by the Shareholders was sufficient for approval.

4. The holders of Common Shares shall exchange one (1) share of such stock for six one-thousandths (.006) shares of Class A Voting Shares and one hundred ninety-four one thousandths (.194) shares of Class B Nonvoting Shares.

5. These Amended and Restated Articles of Incorporation were adopted and approved on the 13th day of December, 2007.

6. These Amended and Restated Articles of Incorporation shall become effective immediately upon filing with the Department of State of Florida.

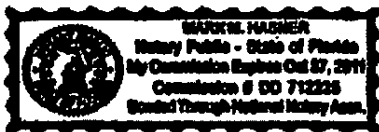


