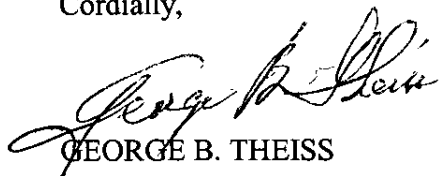
Dear Sirs:
