Dear Sir/Madam;

Enclosed is the \$550 late filing fee, which I have been required to pay by law.

I am aware that my error (misfiling the UBR) is my problem, as it was stated clearly that it must be filed before May 1. However, I did not see anywhere on the front of the form that it was the Annual Report - which we have filed for 24 years - and have always filed early as you can check from your ~~records. We generally sent it in in January or February.~~

So, it does seem a bit steep to lose \$400. because of this change (a confusing change), because we are a very small corporation with little or no profit during our 24 year existence.

Any consideration of leniency, if it is permitted, would be greatly appreciated.
