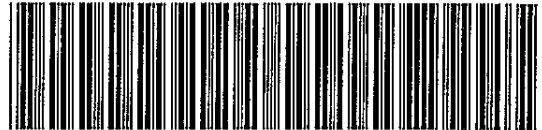

**The name of the corporation shall be "Interior Design Services of Florida, Inc."**


