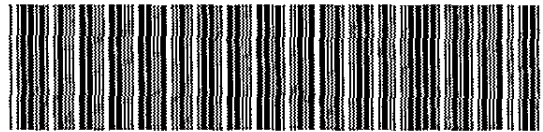

4. The amendment was duly approved by the unanimous vote of all shareholders of the professional corporation in accordance with Section 607.100, Florida Statutes.


