We filed our original 1997 report on January 19th, 1997. It is not due until May 1st, 1997. On August 21st, 1997 they returned our report with our original check and stated in the attached letter we were late and owed an additional fee of \$385.00 for being late. My secretary called the 850-487-6059 upon receipt of that letter and told them this was ridiculous this report was filed 4 months early.

The reply was that they had just received it. After getting nowhere with this conversation, we had no choice but to send the additional \$385.00 for what was either the U.S. Postal Services' mistake or some one in your office mislaid our report. But no one was taking responsibility, so we had to assume the cost.

Now you are informing that my corporation has been dissolved because we could not afford to pay for someone else's mistake within the thirty days, after you held my check for six months before returning it. This is ridiculous and extremely unfair. We have always filed by May, and the year I actual file early it turns into a nightmare.

I would appreciate some consideration for my corporation and a review of my corporations history. I agreed to pay the late fees under pressure from your division the first time, but this time I am very upset that this fee is being levied and find it extremely unfair. It would be cheaper to start a new corporation.

Please advise me to your findings. Since this started I have moved. Please note the above address change.
