**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
SUNCOAST STEEL CORPORATION**

Pursuant to the provisions of Section 607.1006, Florida Statutes, Suncoast Steel Corporation, Inc. (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** The following amendment (the "Amendment") to the Corporation's Articles of Incorporation was adopted by the shareholders on January 24, 2000:

Article I. NAME is hereby amended to read as follows:


**ARTICLE I. NAME**
