Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is **HOLTZMAN, KRINZMAN, EQUELS & FURIA, P.A.** (the "Corporation").
2. Article I. of the Corporation's Articles of Incorporation is deleted and replaced by new Article I., as follows:

**ARTICLE I.**

3. Article VI. of the Corporation's Articles of Incorporation is deleted and replaced by new Article VI., as follows:
