Amendments Adopted: Article I is hereby deleted in its entirety. The following shall be the new Article I: The name of the corporation is KAR CORPORATION.

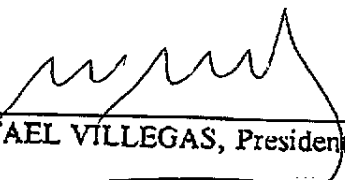
SECOND
