Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendments to its Articles of Incorporation:

The following amendments to Articles I and IV of the Articles of Incorporation of Safe Alternatives Corporation of America, Inc. was adopted on May 14, 2004, as prescribed by the Florida Statutes, by a vote of the shareholders sufficient for approval of the Amendment.

FIRST: Article I. The name of the corporation is MORTGAGE ASSISTANCE CENTER CORPORATION.

SECOND: ARTICLE IV, CAPITAL STOCK, is amended as follows:

The aggregate number of shares which this corporation will have authority to issue is Fifty Million (50,000,000), par value \$0.001 per share.

The effective date of the amendment is January 17, 2005.

No other amendment to the Articles of Incorporation is required for the actions described in this certificate of amendment.


