
1. Article I of the Articles of Incorporation of MCCARTHY HOMES, INC. is hereby amended in its entirety to read as follows:

The name of the Corporation shall be: MCCARTHY WARRANTY SERVICES, INC.


2. The foregoing amendment was duly adopted by a majority of the shareholders of the corporation entitled to vote on such matters on June 7, 1999.
